#### **General Statement**

# **Personal Information**

## **Collection and use of non-personal information**

Non-personal information: data collected for statistical purposes which is not associated with a specific personal identity. This site collects and analyses technical information in order to evaluate our Website. The type of technical information we log is confined to the following:

- The IP address\* of the visitor's Web server
- The top-level domain-name used (for example.ie, .com, .org, .net)
- The pages visited on this Website, i.e. URL's\*\* visited
- The previous Website address from which the visitor reached us, including any search terms used
- Clickstream data which shows the traffic of visitors around this Website (for example, pages accessed)
